# Jean Tyson Center Enrollment Agreement for the 2023-2024 Program Year

This agreement is between the Board of Trustees of the University of Arkansas, acting for and on behalf of the University of Arkansas, Fayetteville – Jean Tyson Child Development Study Center (hereinafter "JTCDSC") and the parent(s) or legal guardian(s) of \_\_\_\_\_\_ [print name of your child] (hereinafter "Child").

In order to provide the best possible educational experience for each child enrolled in JTCDSC and to assist in ensuring appropriate staffing levels, enrollment in the JTCDSC program is offered on a **program session basis**, subject to all policies of the Center, which are incorporated by reference herein. JTCDSC policies are available in the Parent and Family Handbook, provided by email at the beginning of each session and upon request. A paper copy of the handbook is also available upon request.

Adjustments are not made for regularly scheduled school closings such as holidays, parent-teacher conferences, or teacher in-service training. Adjustments are also not made for vacations or weather- or public-health related school closings.

### Terms

- a. Tuition payments are due in full on the first of each month and are considered delinquent after the twentyfifth day of the month. A late fee of \$25 will be assessed on delinquent accounts. Delayed or nonpayment may also lead to termination of enrollment.
- b. This agreement is a binding contract in which you agree to be financially responsible for all tuition and fees for your child for the full session of enrollment that you select below. Subject to all policies of JTCDSC, this agreement can only be terminated by you due to unforeseen family financial hardship, if the enrolled family moves to a location more than forty-five miles from JTCDSC, or upon the consent of JTCDSC.
- c. JTCDSC reserves the right to suspend or terminate services in the best interests of JTDSC and/or its students, consistent with its policies. In the event of termination by JTCDSC, any payments shall be prorated through the final day of enrollment.
